# Activity Report Strengthening Self-Regulatory Mechanism in Timor-Leste Project A-Three-Year Project, I Phase January – December 2018

#### I. INTRODUCTION

In the period of May to July 2018, the Timor-Leste Press Council (TLPC) engaged in two events, which under the project of "Strengthening Media Self-Regulatory Mechanisms in Timor-Leste". The activity such as international travel to Accra, Ghana was organized to bring member of the council to participate in the Press Freedom Day 2018, occurring on May 3rd – 4th. It was aimed at offering chance to TLPC to exchange information and learn from other countries' participants for TLPC's self-improvement.

On the other side, TLPC also conducted a public symposium in July 19th – 20th to bring either national or international media experts discussing about how to enable self-regulatory media bodies in Southeast Asia and the Pacific, and Timor-Leste in particular, as well as its impact on the regions. It is the fact that, freedom of the Press and freedom of expression in Southeast Asia is critical; the region is deadly space for journalists in the context of reporting corruption, good governance, the environment and mega projects. Some journalists in the region should also face legal charges and be imprisoned because of their work in the context of fighting for democracy. On the basis of this, the Dili forum has been a place for the press councils in the regions and other international agencies to put hands together for building a dream network, which could help promote and protect freedom of the press and freedom of expression in Southeast Asia and the Pacific.

This report is to account for the referred two events; international event (The World Press Freedom Day) and public symposium (the Dili Dialogue Forum), which includes the expenses of both activities.

## II. WORLD PRESS FREEDOM DAY

The World Press Freedom Day (WPFD) is one of the highest journalism annual event bringing press actors to discuss and to initiate fundamental actions of the press freedom. This year, the WPFD was organized by UNESCO in Accra, Ghana. Around 300+

media practitioners took part in the main conference and several parallel sessions sharing experiences and learning from one another. TLPC was one of the invitees that took this opportunity as benefit.

Through plenary sessions members of TLC decided to send three representatives to participate in the WPFD, one under UNESCO budget and the other two under TLPC budget. They were Hugo Fernandes, member; Jose Maria Ximenes, member and Ana Teresa Sequeira, executive member.

This year, the WPFD focus on theme of keeping the Power of Checks: Media, Justice, and Rules of Law. Issues that been raised up in the conference is Media Under Fire: Challenges to Press Freedom 27 Years after Windhoek Declaration; Investigative journalism: uncovering election and political malpractice; Challenges of covering election and electoral campaign; Does online speech need regulation or self-regulation?; Artistic freedom of the digital age; Flourishing society and the role of press freedom; Internet shutdown and service restriction; Ethics and risk mitigation; Gender in media industry; Safety Protocols for Journalist; Rule of law and fighting impunity and some specific topics related to Africa region.

TLPC team arrived in Accra on 31<sup>st</sup> of April and 1st of May 2018, one day early ahead to the set date to participate in the WPFD pre-event. One of several pre-events, which was offered to TLPC to participate was the Safety Journalism Training provided by The International Research & Exchanges Board (IREX). Together with trainees from Ghana and other countries, the participants were guided to be safe in their daily work with some exercises, discussions and also theories.

WPFD officially open with a plenary session, on 2<sup>nd</sup> of May and continued with the main conference and also 8 parallel sessions till the end of the day. In the opening plenary session, the keynote speech Nnenna Nwakanma, Senior Policy Manager at the Web Foundation, emphasized that people from the internet and the press share the same



basic principles, they are freedom, independence, safety, plurality and diversity and also gender balance and social justice. So that before she ended her speech she encouraged

others to stand up for freedom, to uphold independence, to promote safety, to encourage plurality, diversity, and gender balance.

TLPC team has also participated in the opening and also main conference that focusing on Media under Fire: What are new challenges to press freedom 27 years after the Windhoek declaration. The session was discussing the current challenges to the freedom of the press and freedom of expression, including freedom of artistic expression.

#### LEARNING OPPORTUNITY

The World Press Freedom Day (WPFD) this year in Accra, Ghana celebrated with African trend as it happened in Africa Continent same as WPFD in Jakarta last year, it was also with Asian trend. "Several parallel sessions were focused on African media's issues such as National mechanism for safety of journalist in Africa and also Promoting journalist's safety and countering impunity for crimes against journalist in Africa. Those topics give us the information how to tackle these issues in our home country if it happened." Said Hugo Fernandes, a member of TLPC who participated in WPFD last year and this year.



On the other side, the Safety Journalism Training help TLPC participants as media practitioners and social communicators to better navigate turbulent situation in order to provide alternatives, independent media to our communities and also the world. The information

and skills that gained from the training is a modal for TLPC. "I think we may share some information on Safety Journalist when we organize journalism training in the future as we already had basic information and also some books as reference. As the aim of IREX is to start delivering ToT for wider and more flexible knowledge transferred, we would appreciate if possible UNESCO to bring trainers to deliver this training to our journalist in Dili, Timor-Leste." said Ana Teresa Sequeira.

Beside the main conference there were parallel session at which it offered several topics to the participants to choose, which is they prefer to participate in it. TLPDC team

spread up and participated in different session such as Investigative journalism: uncovering corruption and political malpractice; covering election and electoral campaigns: old and new challenges in times of media disinformation and also a debate on Does online speech need regulation or self-regulation?

"These sessions provide experience information from people especially online speech that there is a possibility lapsed into hate speech and uncontrolled. Previously, they maintained each other there must be a regulation or enough with self-regulation. Both have their own strengths, but freedom of expression need its own space" said Jose Maria Ximenes when making comments during the session.

TLPC team returned to Dili, Timor-Leste on 6<sup>th</sup> May 2018. The information and experiences that they obtained from this oversea travel was shared in plenary session of member, including several books as references to place in the TLPC's library catalogue.

#### III. DILI DIALOGUE FORUM

Since its inception in May, 10th 2016, TLPC celebrated its first anniversary in 2017 by organizing an international conference, which was about promoting freedom of the press and freedom of expression in the regions at which representatives of all Press Councils in Southeast Asia and the Pacific took part in it. In the end of the conference, the representatives of the regions' press councils officially issued a declaration called the Dili Declaration. The Dili Decoration was adopted from the Jakarta Declaration declared in the World Press Freedom Day on 3rd May 2017.



The Dili Declaration was made to help facilitate establishment of appropriate network to protect the local and regional journalists for full endorsement of rights. Therefore, 2018 the TLPC organizes international conference as a followup action on the declaration. The conference called the Dili Dialogue Forum (DDF) held in Dili on 19-20 July with central theme "Strengthening Media Self-Regulatory Mechanism in Asia and the Pacific". In regard to the theme, under the Strengthening Media Self-Regulatory Mechanism project, UNESCO and TLPC organized it to bring overseas participants, which include the representatives of Press Councils, Southeast Asia Pacific Alliance (SEAPA), International Federation of Journalist (IFJ) expert and also another related International speakers such as Indonesian Broadcasting Commission (KPI) and Reporter Sans Frontiers. From the local level, Public Prosecution Office), National Election Commission (CNE), Technical Secretariat for Electoral Administration (STAE) and National Police Force (PNTL) representatives were also invited.

The two-day conference brought national and international speakers with several topics of speeches, such as strengthening existing media self-regulatory mechanisms, how media self-regulatory mechanisms enable journalism practice, regional media self-regulatory mechanisms and its functions and challenges, good governance in democracy building, legal framework to strengthen independent media in elections and how to tackle hoax and disinformation in social media nowadays.

Almost 300 people include journalists, the media practitioners, civil society organization members, representatives of the government entities, and diplomatic corps were present in the Dili Dialogue Forum. The conference was officially opened by the Secretary of State for Social Communication Mr. Mericio Juvenal Akara and was closed



by Head of Presidential House Mr. Francisco Maria de Vasconselho on the second day. It was scheduled to be officially opened by the country's Prime Minister and closed by the President of Republic but unfortunately both head of state and head of the governments were not able to come to the conference because of the debate of newly-elected government's programs in the National Parliament. The forum also tented to bring Mr. Xanana Gusmão and Mr. Ramos Horta as keynote speakers but only Mr. Horta was able to deliver his speech, while Xanana was unable as he was busy with the new government's cabinet members who are going to be sworn-in.

#### THE OUTPUT OF THE DILI FORUM

Dili has been the center for Southeast Asia and the Pacific and the window of DDF in the regions

As it is indicated in the Dili Declaration in 2017, the Dili Dialogue Forum is aimed to establish a regional networking to support and strengthen freedom of the press and freedom of expression. However, considering the different characters and nature of the press councils (and even some of them are center, not as council yet) the round table discussion more focus on exploring ideas. Even, the forum did not produce any declaration, however the issue has been officially discussed among the press councils and media centers' representatives of the region during the conference.

This year's forum was attended by the representative of UNESCO Jakarta and also the Philippine media center, apart from the Dili Declaration declarative Indonesia, Papua New Guinea and Thailand. New Zealand Press Council is willing to support all outputs of the forum; even it did not participate in it directly. This forum also missed Australia and Myanmar presences as declaratives.

TLPC will send the ideas of building up the networking to all press councils in the regions for the next step actions.

#### IV. EXPENSES OF THE ACTIVITY

This year, 2018 after the election in 2017 and early election this year, Timor-Leste facing uncertain politic situation that also affects directly the Press Council's programs. The impact of the current political deadlock puts the state in the situation of no state budget almost for a year. The Government adopted monthly based budget with limitation of amount and with several implementation policies include no overseas travel but after few months the policy has changed that there is but it should be by the approval of the Prime Minister.

On the other hands, TLPC has one international seminar this year. Throughout the efforts, the proposal for organizing it was approved by Prime Minister Marri Alkatiri at that time as one of activity. Based on the approval, TLPC started organizing the Dili Dialogue Forum and went through a discussion with Jakarta-based UNESCO about the forum and that was organised under the budget of public symposium activity, as part of one of activity project. In fulfilling the expenses of the international event, TLPC also

approached some donors asking for funding where it funded with, especially for airfare granted to the international speakers, venue, fee for districts participation as well as, documentations, publications and printing.

The following information is about the second instalment of USD 24'364.00 being transferred to financing the activities of WPFD and also public symposium, the Dili Dialogue Forum.




